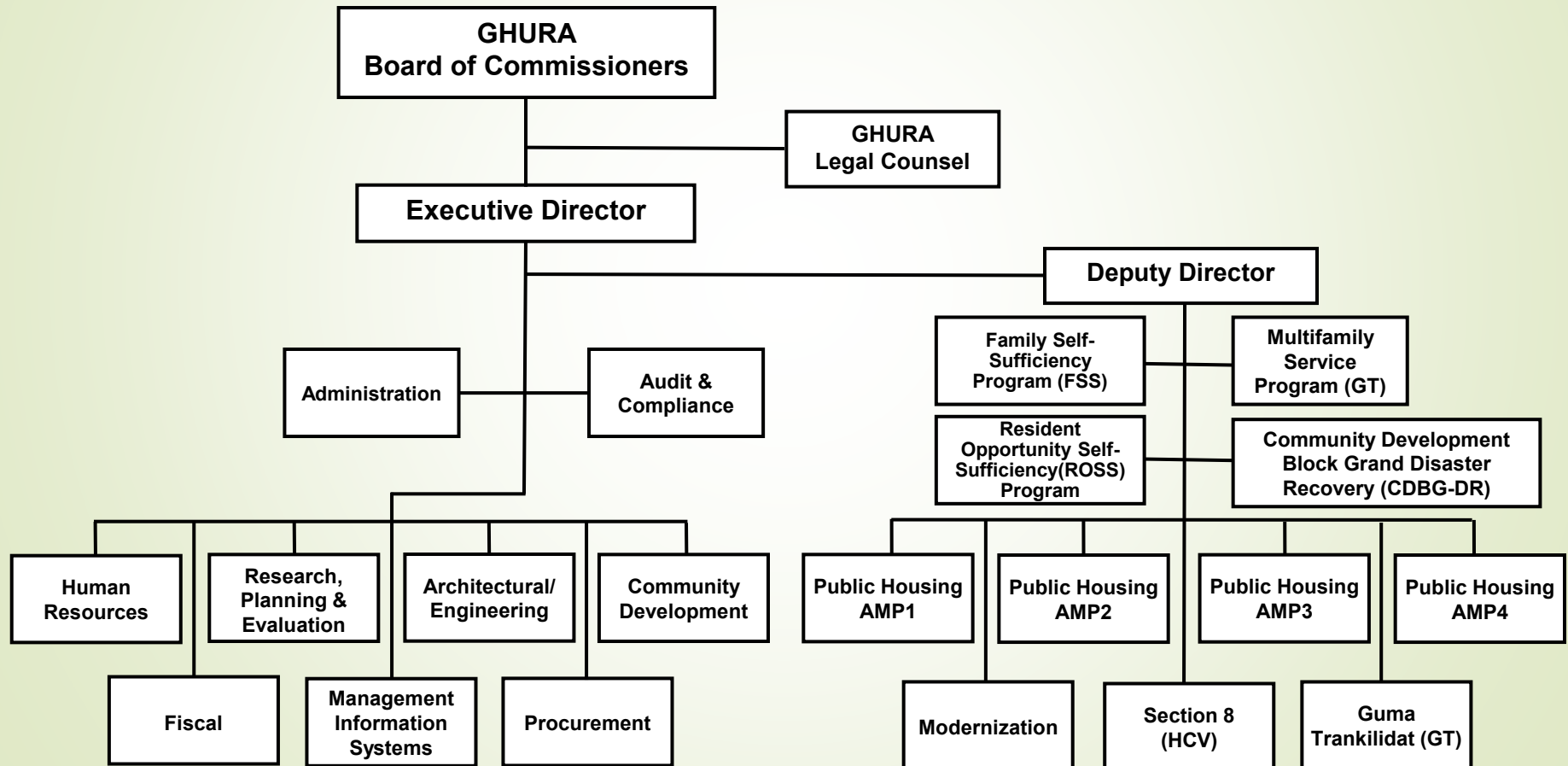

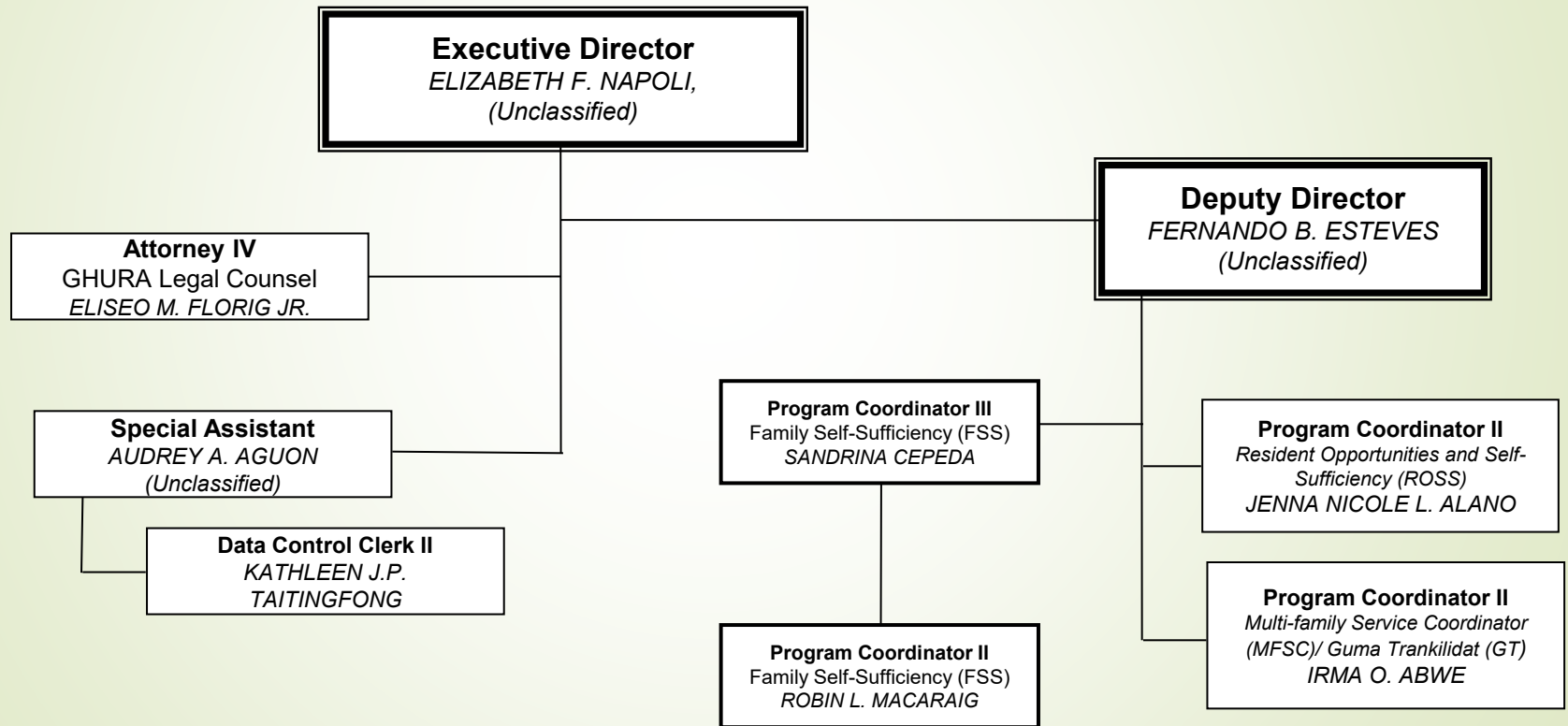

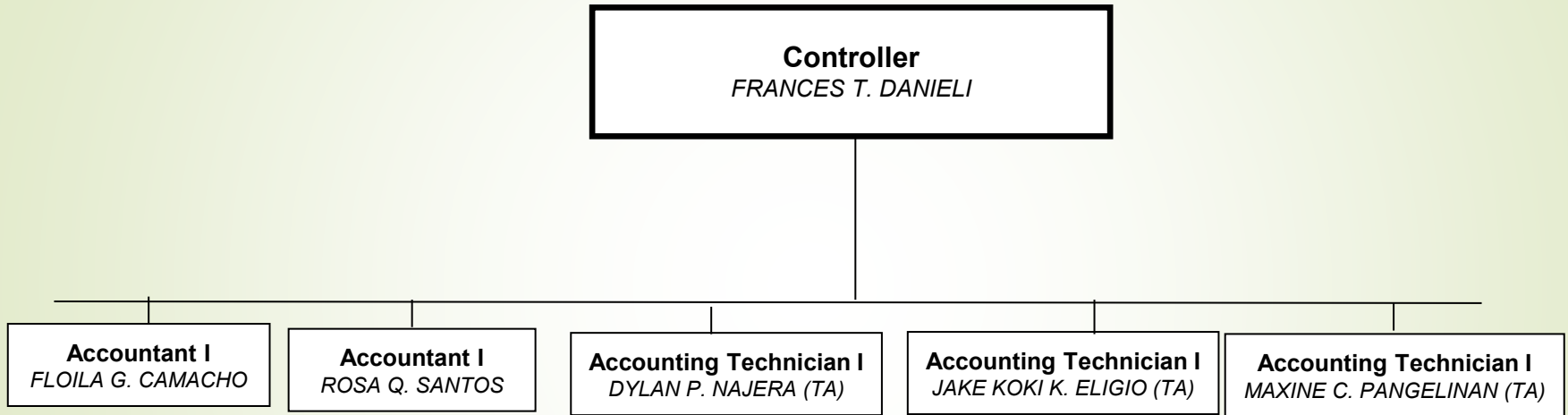

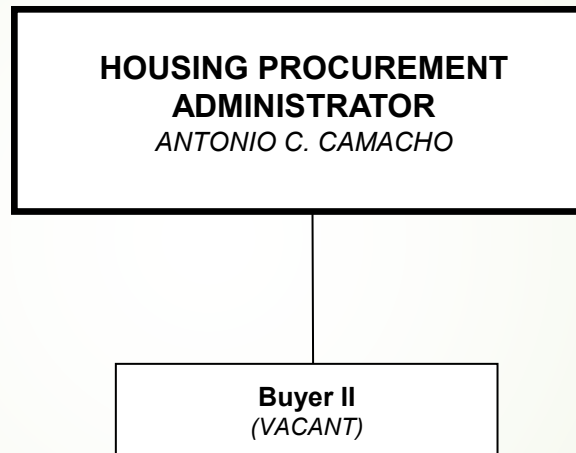

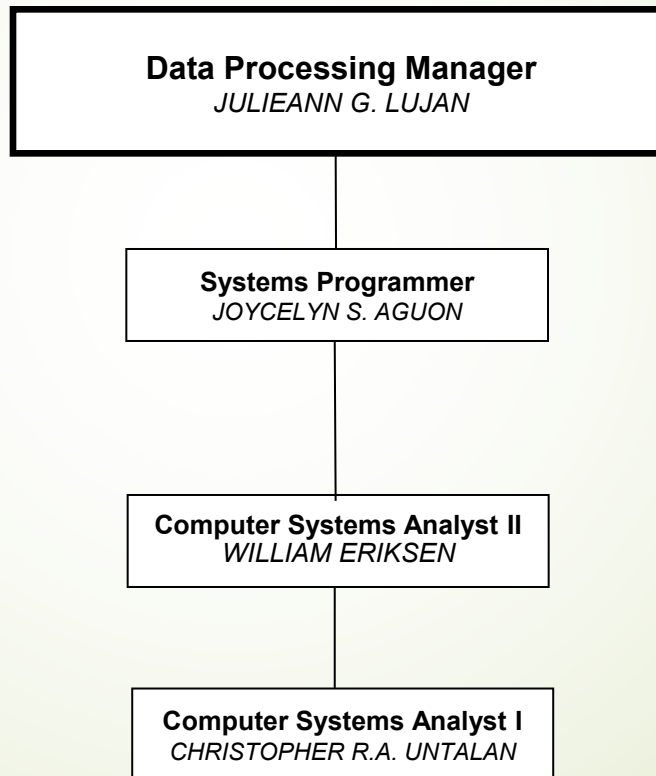
FY2026 Organizational Chart PROCUREMENT

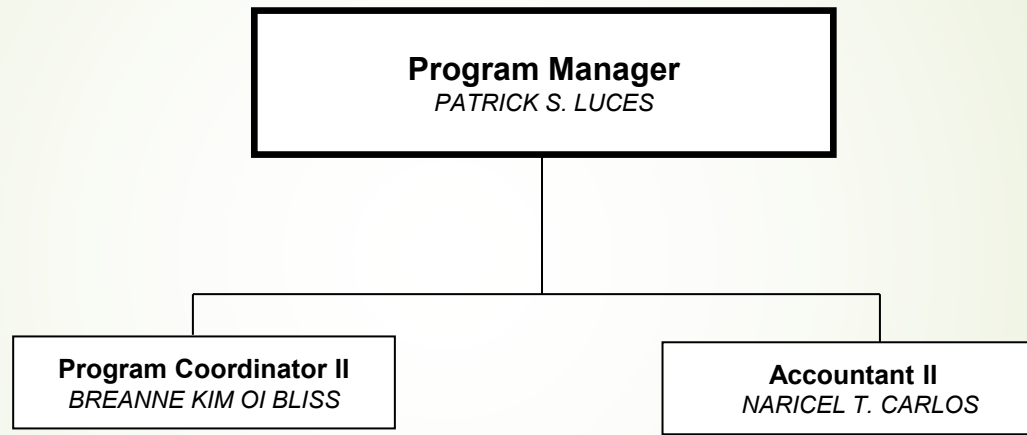
FY2026 Organizational Chart MANAGEMENT INFORMATION SYSTEMS

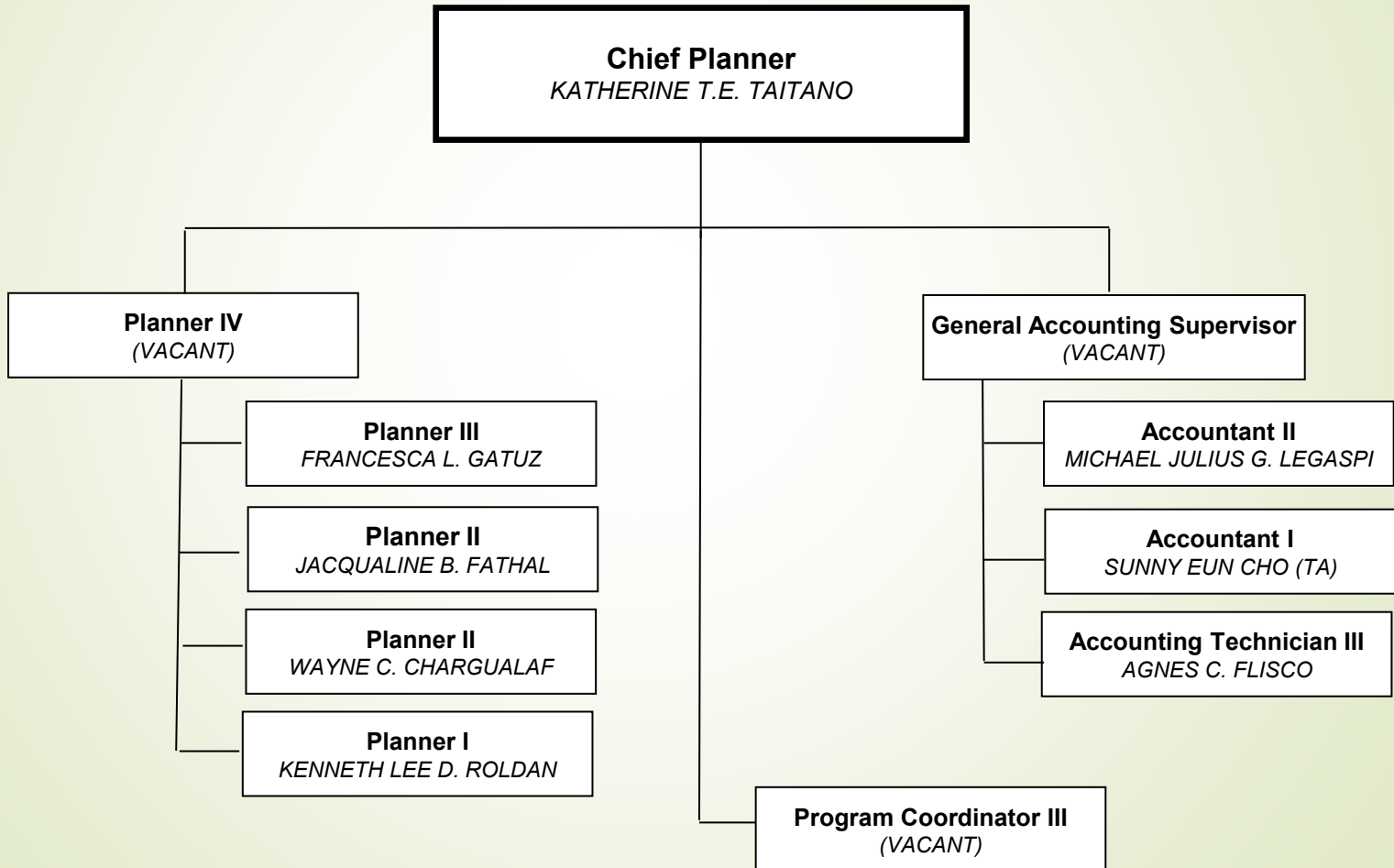
FY2026 Organizational Chart MODERNIZATION (CFP)

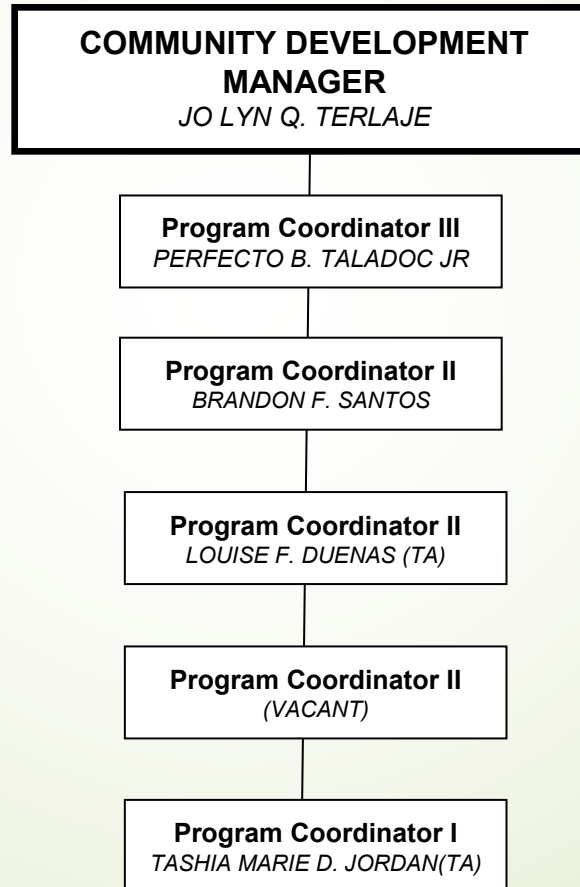

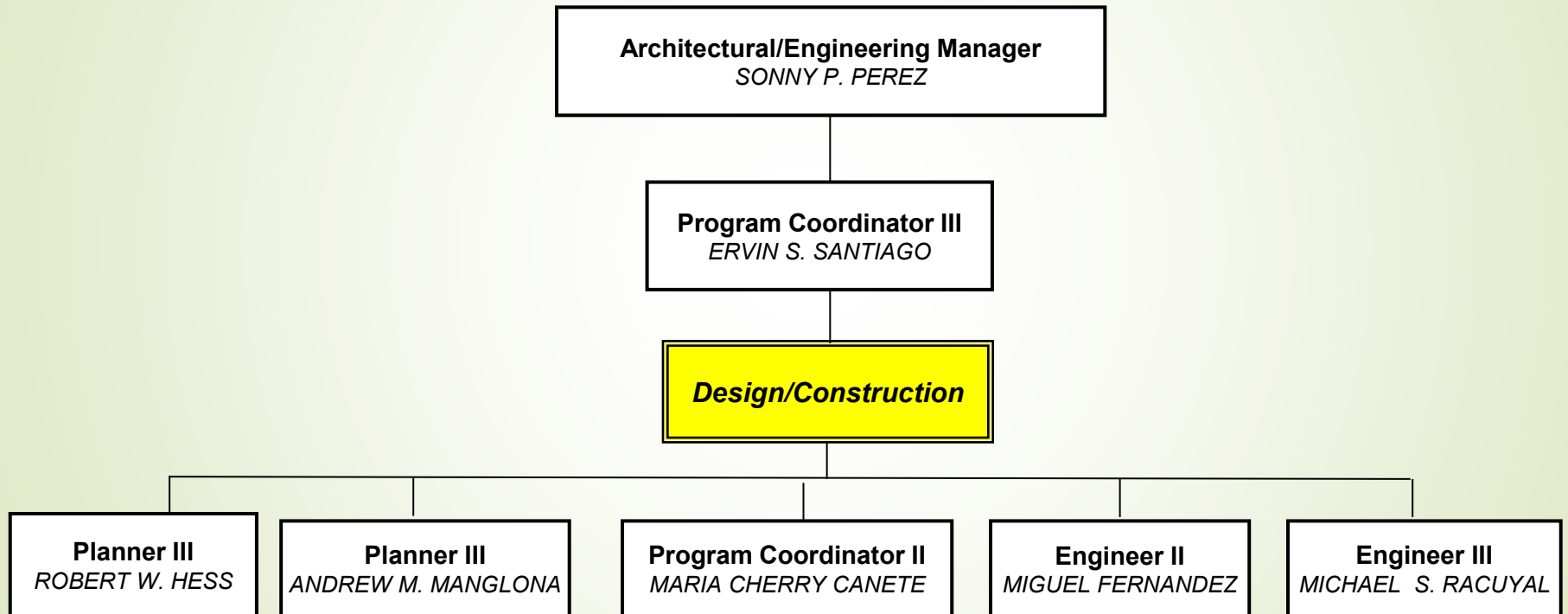
FY2026 Organizational Chart COMMUNITY DEVELOPMENT

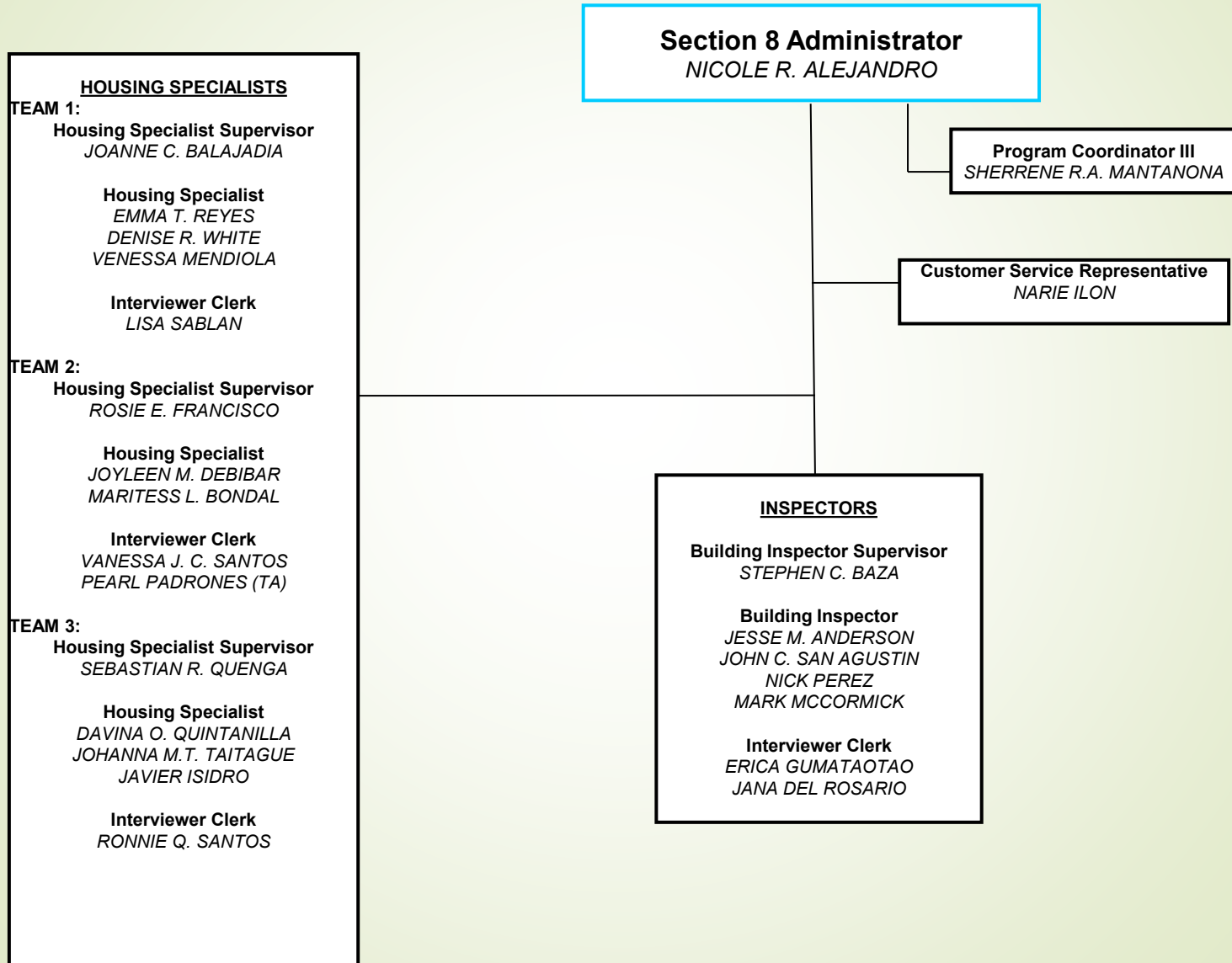

SECTION 8 (Housing Choice Voucher Program)

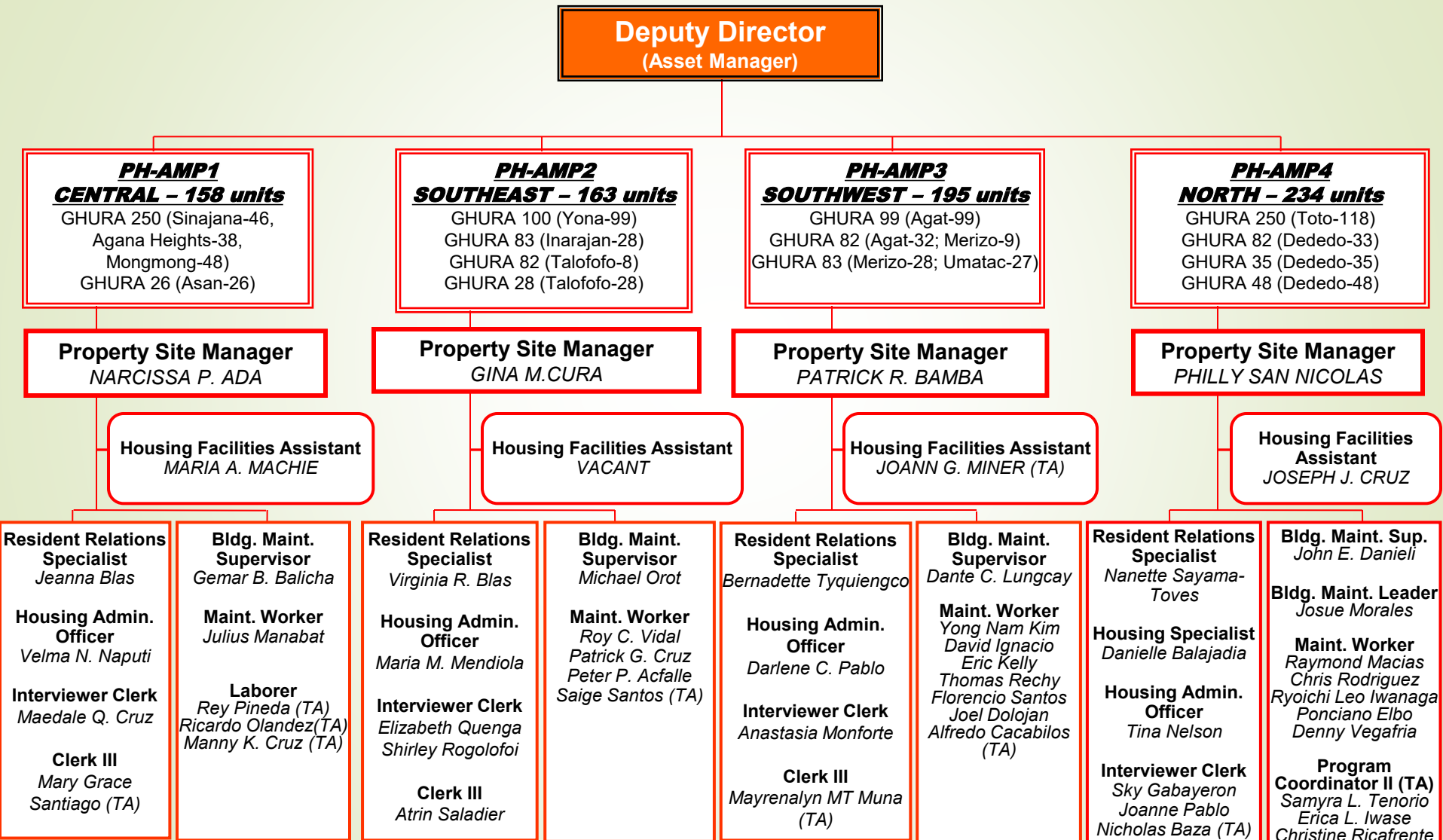

PUBLIC HOUSING - Asset Management Program

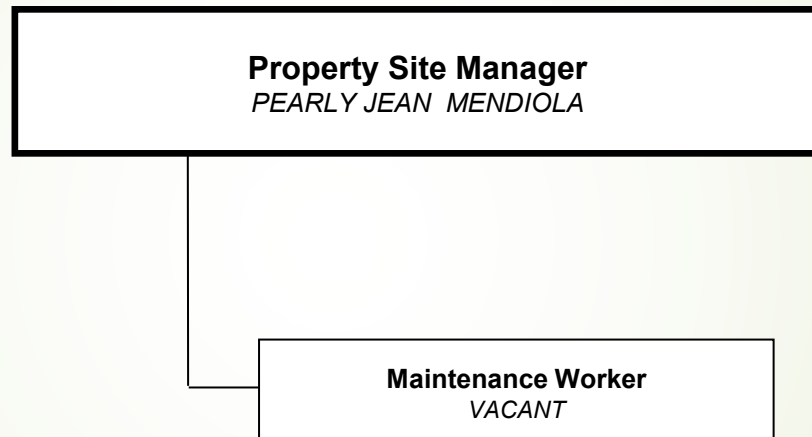
