### 1. GHURA FORM 01B - Section Business Concern


- If you are a business concern, you will need to fill out a business form certification with documents to support your claim. This must be filled and signed at the time of bid/proposal.

# The Guam Housing and Urban Renewal Authority Section 3 Income Limits

## Eligibility Guidelines

The workers income must be at or below the amount provided below for an individual (household of 1) regardless of actual household size.

### Section 3 Worker Definition:

- A low or very low-income resident (the worker’s income for the previous or annualized calendar year is below the income limit established by HUD); or
- Employed by a Section 3 business concern; or
- A Youth Build participant

### Targeted Section 3 Worker Definition:

- Employed by a Section 3 business concern or
- Currently meets or when hired met at least one of the following categories as documented within the past five years:
  - A resident of public housing; or
  - A resident of other public housing projects or Section 8-assisted housing; or
  - A YouthBuild participant.
