Question #1

Bid Item #1 – Would GHURA be able to provide device layouts for all sites? **Response:** GHURA will coordinate with the current service provider to map out the devices. Once the layout is provided, GHURA will disseminate the information.

Question #2

Bid Item #1 – Would GHURA be able to provide information for existing equipment such as make and models for each location?

Response: GHURA will coordinate obtaining the information from the current service provider and disseminate the information once provided.

Questions #3

Bid Item 1 & 2 – What is the contract term for this service request?

Response: The contract term is for one year with the option to renew for two (2) additional one year terms.

Questions #4

Are we to provide hourly rates per location?

Response: Please provide hourly rates for Guma Trankilidat and AMP 4 Elderly due to both sites requiring regular roving services. And an hourly rate for the remaining sites on an as needed basis.

Question #5
