Substantial Amendment to the Program Years 2019, 2020 and 2021 Annual Action Plans (AAP) and Reprogramming of Emergency Solutions Grant (ESG) Funds

The Guam Housing and Urban Renewal Authority (GHURA) is requesting public comment regarding the proposed Substantial Amendment to the Program Years 2019, 2020 and 2021 Annual Action Plans and the reprogramming of EMERGENCY SOLUTIONS GRANT (ESG) funds from an approved project to an on-going project.

The proposed Guma Manhoben project for the consecutive Annual Action Plans have triggered the need for a substantial amendment to cancel funding and reprogram funds into the on-going (2019/21) ESG20 GUAM (Catholic Social Service Liheng Sinafo; Temporary Emergency Shelter) to allow for the continued support of the Shelter and timely expenditure prior to Guam's April 28, 2023 deadline.
