## **ADDENDUM NO. 1**

November 29, 2021

## General Intent:

This Addendum shall form a part of the Contract Documents. It is the intent of this Addendum to make clarifications and issue changes to the Specifications of the Bidding Documents.

Listed below are additionional work items made to the scope of work:

#### Basic Bid #1

# 1A ATIS CT., GHURA-250, SINAJANA (3-bedroom)

- 1. All existing interior hollow core doors to be replaced with solid core door with new knob and hinges, work to include paint finish (color to match existing in-kind).
- All exterior doors (entry, exit & storage doors) to be removed & replaced with new Aluminum door and frame, entry & exit doors to include security screen door panel.

# 9A CALLE DAMIAN, GHURA-250, TOTO (4-bedroom)

 Interior hollow core doors (3each) to be replaced with solid core doors with new knob and hinges, work to include paint finish (color to match existing inkind).

#### Basic Bid # 2

### 41MAO DR., GH-99, AGAT, (3-bedroom)

1. Provide complete interior painting at all areas.

#### 84 MAO DR. GH-99, AGAT (2-BEDROOM)

- 1. All existing interior hollow core doors to be replaced with solid core door with new knob and hinges, work to include paint finish (color to match existing in-kind).
- All exterior doors (entry, exit & storage doors) to be removed & replaced with new Aluminum door and frame, entry & exit doors to include security screen door panel.
- 3. Remove & replace all vinyl tiles (new type and thickness to match existing inkind). Apply two coat minimal wax.
- 4. Clearstory infill with new metal frame and 1/2inch cement board, seal and spackle all joints and provide paint finish.
- 5. Complete interior painting required throughout the unit.



# 134 S. DOYLE, GHURA 83, MERIZO (3-BEDROOM)

- 1. All existing interior hollow core doors to be replaced with solid core door with new knob and hinges, work to include paint finish (color to match existing in-kind).
- 2. Complete interior painting required.
- 3. Fixed window at left of FRONT entrance door to be removed. Infill area with 8" CMU. Plaster and paint to match surrounding wall from top of slab to mid height. Infill remaining area with reinforced glass block. "DELETED".

## 184A JQQ GHURA 83 UMATAC (3-BEDROOM)

1. Waterline (HW & CW) replacement work to include waterline to existing shower valve assembly (existing shower valve assembly to remain). The new waterline to shower shall be surface mounted, point of connect where lavatory supply line occurs.

# A20, UPPER AGAT (1-BEDROOM)

- 1. Complete interior painting required.
- 2. Existing pipe chase waterline leak occurs at two joint fittings to be repaired (3/4inch copper line joint reweld).
