Would it be best to make the water tank as an option since we still don't know if the water flow test will pass or fail until the contract is awarded and the testing is conducted?	The Water tank, piping, and water tank structural support, reinforced foundation, pumps and controls, and any other water tank appurtenances requirements will set as BASE BID 2. Contractor will submit separate quotation; the water flow test is part of the base bid 1.
